A man of noticeably calm demeanour, and a national of St. Vincent and the Grenadines. Bishop Williams is an Ordained Minister and the Pastor of the Glad Tidings Tabernacle, in Gomea, SVG, where he has served for the past nineteen (19) years.

Having been given the mandate by the PAWI General Conference to lead this indigenous regional organization, Bishop Williams assumed his new role in September 2018, following an official hand-over ceremony involving his predecessor Rev. Dr. Pat Glasgow.


Bishop Williams' election to this position has shattered a longstanding record, in that, he is the first non-Trinidadian to be elected to the position of General Bishop in the history of the organization. As the Presiding District Bishop of PAWI's St. Vincent and the Grenadines District, Bishop Williams has served on PAWI's General Executive for the past 16 years. As such, he brings to the office, a vast amount of leadership experiences and successes and long-standing working relationship with the executive team.

A shepherd and an educator at heart, Bishop Williams taught for more than thirty years. He worked as a primary school teacher as well as a lecturer at two theological institutions. He continues to be a regular speaker at school and corporate functions on the Island of St. Vincent and the Grenadines, and indeed a true son of the soil. Some of his qualifications include: A Master's Degree in Counselling, a Bachelor's Degree in bible and Theology, a Caribbean Regional Certificate in Addiction Studies and a Certificate in Educational Management and Supervision.

DECISIONS OF THE GENERAL EXECUTIVE

1

The dates for General Conference will be determined after the Venue is decided. That we consider having General Conference in Miami as a first option and St. Lucia as a second option. The General Administrator would be given one month to communicate information re a resort and a venue to host the conference. Bishop Eristhee is to do the same in the same time frame.

That Districts will forward their concerns regarding the inconsistencies in the Constitution and By-laws to the Administrator. A response from the constitution committee will be given at the next meeting.

Bishops are to ensure that all churches in their district are compliant with the PAWI branding policy. (including the proper use of the Logo on their church signs, etc). The branding policy can be viewed and downloaded from the PAWI website.

4

Strategic plans for all churches are required and that churches ministry be assessed using the approved and submitted strategic plan. These strategic plans must be related to the local district and Fellowship's strategic plans. February be declared PAWI PAWI Month throughout Districts. Some suggestions for the month will be to ; Design Bumper Stickers, host Quizzes, Give Gifts, Give Incentives, etc. A PAWI day offering is to be taken and forwarded through the districts to the International Office. WIST Day will be placed in the PAWI Month and be used to promote the institution, an offering will also be collected for the school.

PAWIMA gave approval to Antigua District to utilize the 100 % undesignated missions remittances to support St.Maarten and Guadeloupe Missions Initiatives. A report of all funds expended is to be sent to PAWIMA monthly In relation to the issuing of Credential for the Fivefold gifts: Bishops are to disseminate the document that was developed and passed by the General Executive in 2012. The matter shall be fully ventilated and discussed at the districts and a program of education regarding same be developed, promoted and initiated. The District Executives must designate (recommend) to the General Executive what is to be conferred on each applicant.
